

## Driving Directions To Our Offices

**From I-275:** Take I-275 to the Busch Blvd. Exit (approximately 6 miles north of downtown Tampa). Proceed west on Busch Blvd (go under the I-275 overpass if coming from the south). Drive approx. 2.3 miles & make a right turn at the light at Orange Grove Dr. (Orange Grove is located between Himes Ave. & Armenia Ave). Then make an immediate right into the parking lot. The building name is the Financial Center and it is a stand-alone 2 story structure, mostly brick. There is no charge for parking.

**From Dale Mabry Highway:** Take Dale Mabry to Busch Blvd. and go east (left turn onto Busch Blvd.). At the traffic light at Orange Grove, make a left turn and then an immediate right into the parking lot.

**From Tampa International Airport or from SR60 coming from Clearwater:** Take the Veterans Expressway (SR589) North to the Anderson Rd. exit. At the end of the exit ramp there is a traffic light. At the light, make a left onto Anderson Rd. and get into the right lane. At the next traffic light, make a right onto Linebaugh Avenue and take it to Gunn Highway. At Gunn Highway, make a right turn and go under the Dale Mabry Highway overpass and you are now on Busch Blvd. Continue to Orange Grove Rd. and make a left onto Orange Grove and an immediate right into the parking lot.

**From I-4:** Take I-4 West to I-275 North to the Busch Blvd. exit. and follow directions from I-275.

**From I-75 South of Tampa or North of Tampa:** Either way, take I-75 to I-275 and follow the directions from I-275 above.

Chris is an Adjunct Professor at Stetson University College of Law. He is also a Senior Adjunct Instructor at Keller Graduate School of Management's Tampa campus, where he has taught Business Law and Ethics, Employment Law, and Negotiations since 1999.
